## AMOS FAMILY BICENTENNIAL - TERMS AND CONDITIONS 2021

This ticket has been created and managed using the TryBooking site and is also subject to the Terms and Conditions of TryBooking

Patrons must follow the direction of Event staff regarding areas for admission, parking of vehicles, setting up campsites and any COVID 19 related control measures as required. The Event Organiser reserves the right to refuse entry.

As part of the Event's liquor licensing regulations, Patrons are strictly prohibited from bringing alcohol into the Event (including camping areas). Alcohol will only be available to purchase at the Event for Patrons over 18 years old with valid photo ID.
